

Norfolk Exemptions 1917

As World War I dragged on, Canada found it necessary to implement a draft (conscription) in an attempt to keep Canada's armed forces at the 500,000 mark promised by the Prime Minister.

During November 1917, local Tribunals heard Exemption requests. Norfolk County had two Tribunals: number 209, made up of Judge Boles, Warden Cridland and Colonel H. B. Donly; and Tribunal 210 consisting of Crown Attorney T. R. Slaght, ex-Warden George J. McKiee, and Colonel L. F. Aiken.

Exemptions were granted based on age, disability, religion, hardship, student status, etc. Those with jobs considered vital to the economy were also exempted. In Norfolk over 800 exempts were sought. Most were granted for employment reasons. (Agriculture was considered vital to the economy.)

The following is an alphabetically re-sequenced, summary list of those requesting exemption in Nov 1917, and the outcome of each appeal. This list is not a transcription of source documents. Rather, it is a merged, edited, re-sequenced summary of several lists published in *The Simcoe Reformer* of 15 Nov 1917 (page 1), of 22 Nov 1917 (pages 1, 6, 7) and of 29 Nov 1917 (page 11). The 6 Dec 1917 *Reformer* said there were still a dozen or so adjourned cases to decide, but no list of those cases was found in subsequent issues.
